TAYLOR vs TAINTOR 83 U.S. 366 CONN. 1873 U.S. SUPREME COURT**

IN ACCORDANCE WITH SAID STATUTE, WHEN BAIL IS GIVEN, THE PRINCIPAL IS REGARDED AS DELIVERED TO THE CUSTODY OF HIS SURETIES (BONDSMAN). THEIR DOMINION IS A CONTINUANCE OF THE ORIGINAL IMPRISONMENT WHENEVER THEY CHOSE TO DO SO. THE SURETY, BAIL BONDSMAN, OR HIS AGENT MAY SEIZE HIM/HER AND DELIVER HIM/HER UP IN THEIR DISCHARGE, AND IF THIS CANNOT BE DONE AT ONCE, THEY MAY IMPRISON HIM/HER UNTIL THAT CAN BE DONE. THEY MAY EXERCISE THEIR RIGHTS IN PERSON, OR BY AGENT. THEY MAY PURSUE HIM/HER INTO ANOTHER STATE, MAY ARREST ON THE SABBATH, MAY BREAK AND ENTER HIS/HER HOUSE FOR THAT PURPOSE.
